OCCUPATIONAL THERAPY LIST OF PROVIDERS WITH BOARD APPROVED PREVENTION OF MEDICAL ERRORS COURSES

SECTION 456.013(7), FLORIDA STATUTES, REQUIRES COMPLETION OF A 2-HOUR COURSE RELATING TO PREVENTION OF MEDICAL ERRORS AS PART OF THE LICENSURE AND RENEWAL PROCESS. RULE 64B11-5.001(5), FLORIDA ADMINISTRATIVE CODE, STATES: "EACH LICENSEE SHALL ATTEND AND CERTIFY ATTENDING A BOARD-APPROVED 2-HOUR CONTINUING EDUCATION COURSE RELATING TO THE PREVENTION OF MEDICAL ERRORS. THE 2-HOUR COURSE SHALL COUNT TOWARD THE TOTAL NUMBER OF CONTINUING EDUCATION HOURS REQUIRED FOR LICENSURE RENEWAL. THE COURSE SHALL INCLUDE A STUDY OF ROOT-CAUSE ANALYSIS, ERROR REDUCTION AND PREVENTION, PATIENT SAFETY AND MUST INCLUDE CONTRAINDICATIONS AND INDICATIONS SPECIFIC TO OCCUPATIONAL THERAPY MANAGEMENT INCLUDING MEDICATION AND SIDE EFFECTS."
