## SETTLEMENT AGREEMENT

**TAB 2 Michelle Nicole Perry Burkhard, DOH Case No.2015-05111, OTA 9958, File #2824 Settlement Agreement, (PCP Members - Johnson and McKenzie)**

Michelle Nicole Perry Burkhard, Respondent, was not present and was not represented by legal counsel. This case was tabled until the end of meeting to see if Ms. Burkhard may appear as her appearance was expected by Ms. Gilani.

**TAB 3 Kellie Lynn Casto, DOH Case No.2015-04367, OTA 10961, File #3887 Settlement Agreement, (PCP Members - Johnson and McKenzie)**

Kellie Lynn Casto, Respondent, was present, not represented by legal counsel, and sworn in by the court reporter.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violations: Section 468.217(1)(t), Florida Statutes unable to practice occupational therapy with reasonable skill and safety (2014), and Section 456.072(1)(x), Florida Statutes (2009-2014) failure to report criminal pleas or convictions to the Department, in writing, within 30 days. Respondent did not dispute allegations, and agreed to enter into a settlement agreement to address impairment issues. Respondent agreed to be suspended from practice until found safe to practice by PRN. The Settlement Agreement ensures the safety and welfare of the public as the Department's appropriate resolution to the case. Suspension of license begins, upon the filing of the final order.

Pages 4 and 5 of the Settlement Agreement in the Board agendas were revised, regarding full payment of costs (\$1,109.30) were initialed by respondent, and distributed at the meeting, for attachment to the final order.

The case was presented as a Settlement Agreement that would impose the following:

- Reimbursement of Costs of \$1,109.30
- Indefinite suspension from practice until PRN determines Respondent safe to practice

## SETTLEMENT AGREEMENT

### TAB 2 Michelle Nicole Perry Burkhard, DOH Case No.2015-05111, OTA 9958, File #2824 Settlement Agreement, (PCP Members - Johnson and McKenzie)

Michelle Nicole Perry Burkhard, Respondent, was not present and was not represented by legal counsel.

Ms. Burkhard's case was on the November 2015 agenda and tabled, until her appearance before the Board.

**MOTION:** After discussion, Ms. Roeck-Simmons made a motion to waive the licensee's required appearance at the meeting and proceeded to review the Respondent's case. The motion was seconded by Mr. Spafford and carried with a 3/0 vote.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violation: Sections: 468.217(1)(x) and 456.072(1)(aa) Florida Statutes (2013). This is a one count Administrative Complaint which alleged the Respondent tested positive on a pre-employment drug screening in violation of the Florida Statutes. Respondent tested positive for methadone and marijuana on a pre-employment drug screening on or about March 17, 2014.

In response to this complaint, Respondent has submitted several letters of recommendation and her explanation of what occurred. Respondent did not dispute the issues of material fact alleged in the Administrative Complaint, and agreed to enter into a Settlement Agreement to resolve this situation.

Terms of Settlement Agreement:

- Reprimand
- Reimbursement of Costs
- PRN Evaluation (and compliance with any recommendations)

**MOTION:** After discussion, Mr. Hicks made a motion to reject the Settlement Agreement as drafted. The motion was seconded by Mr. Spafford and carried with a 3/0 vote.

**MOTION:** Mr. Hicks made a motion to approve the Counter Settlement Agreement with the proposed amendments in paragraph 3 as stated in the proposed handout (requiring a PRN evaluation within 3 months of the filing of the Final Order and submitted to Compliance.) The motion was seconded by Mr. Spafford and carried with a 3/0 vote.

**MOTION:** Mr. Hicks made a motion to allow the Respondent 7 days from the date of the Final Order is filed to respond to the Counter Settlement Agreement. The motion was seconded by Mr. Spafford and carried with a 3/0 vote. Response to be provided to the Board Counsel.

Costs included in the proposed Counter Settlement Agreement stated as: \$1,218.95.
