SETTLEMENT AGREEMENT

TAB 1 TAB 3 Traci Leigh Fox, OT 3448, File # 3257, DOH Case #2015-18935 (PCP Members - Johnson and Spafford)

Traci Leigh Fox was present, sworn in by the court reporter, and was represented by Allen Grossman, Esq., Grossman, Furlow & Bayo, LLC, Attorneys at Law, 2022-2 Raymond Diehl Road, Tallahassee, FL 32308.

Mr. Spafford was recused due to previous service on the Probable Cause Panel.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following

violations: Section: 468.217(1)(i), Florida Statutes (2014). The Administrative Complaint alleged Respondent made or filed a report which she knew to be false when Respondent completed, signed, and submitted occupational therapy treatment notes for treatment not rendered.

Respondent indicated that she treated Patient L.H. on November 4, 2014 for 43 minutes when she was only present in the patient's home for approximately 15 minutes and only dropped off supplies and took measurements for wheelchair footrest covers she was going to custom-make. Respondent stated her justification for this was that she was spending a lot of time outside of the visits, designing, purchasing and sewing the cushion covers for the patient's wheelchair footrests. Respondent stated it was not her intent to deceive anyone. Respondent has entered into this Settlement Agreement to resolve this matter to the satisfaction of the Board.

Ms. Gilani stated the Disciplinary Guidelines as set in Section 468.217(1)(i), F.S. (2014), First Offense: From 1 year probation with conditions and a \$100 fine up to 6 months suspension, 1 year probation with conditions, and a \$250 fine.

The case was presented as a Settlement Agreement that imposed the following terms:

- 4 months' suspension
- Continuing education to be completed during the suspension period (4 months).
 - 1 continuing education course in recordkeeping and/or proper patient documentation.
 - Clock hours to be determined by the Board.
 - 1 continuing education course in ethics and professionalism in the practice of occupational therapy.
 - Clock hours to be determined by the Board.
- \$250 Fine, to be paid within 1 year.
- \$1,544.49 Costs, to be paid within 1 year.

MOTION: After discussion, Ms. McKenzie made a motion to accept the Settlement Agreement. The motion was seconded by Ms. Banta and carried with a 2/0 vote.

Ms. McKenzie amended the motion to determine the continuing education hours as 8 hours for each, in ethics and record keeping. Additionally discussed, continuing education approval to be sent to the Compliance Officer when completed, which will be referred to the Vice Chair, Ms. McKenzie for final approval, as delegated authority for the Board. Ms. Fox is to submit the proposed courses addressing the issues for Board review and approval, within 30 days of the filing of the order, and only take such courses after the Board's delegate approves the "proposed" courses. Ms. Fox, will then have 4 months to provide proof of completion. The motion was seconded by Ms. Banta and carried with a 2/0 vote.

Mr. Grossman inquired if Ms. Fox was not able to find available live lecture courses within the 4 month period, would she be able to request additional time from the Board. Ms. McNulty advised it would be appropriate to submit a request to the Compliance Officer as the Settlement Agreement includes an extension of time clause.

REQUEST FOR MODIFICATION OF BOARD ORDER

8. Jeremiah Klotz, OT by Endorsement, File #16964

Mr. Klotz was not present and was not represented by legal counsel.

Mr. Klotz submitted a request for the modification of a previous Board Order, requiring supervision, and an extension for repayment of fines.

MOTION: After discussion, Mr. Spafford made a motion to deny the request for modification of the Board's previous final order regarding the modification of Mr. Klotz's supervision, including denial of specific request to work in Home Health Care without direct supervision. The Board granted the extension of time request, to include a year's allowance to pay the initial \$4,000 first payment, due on 11/13/2016, until November 13, 2017. The motion was seconded by Ms. McKenzie and carried with a 3/0 vote.

PETITION FOR DECLARATORY STATEMENT RE: RULE 64B11-4.001, F.A.C., USE OF PRESCRIPTION DEVICES

9. Antrelise Gantt, OT9286, RE: Hivamat 200, Deep Oscillation Therapy Device

Ms. Gantt is employed at Lymphatx, where she works with a team of therapists whose sole focus is the treatment of edema and lymphedema. In therapy treatment at Lymphatx is the use of a modality called a Hivamat 200, approved by the FDA for deep oscillation therapy. Ms. Gantt stated in her petition the only Prescription Devices identified in the Florida Practice Act are: (1) Electrical Stimulation Device, and (2) Ultrasound Device, specifying, Rule 64B11-4.001 (1)(a), "causes concern as being broad and might give the impression that modalities other than Electrical Stimulation and Ultrasound are prohibited devices."

64B11-4.001 (1)(a) Use of an electrical stimulation device for which a prescription is required by Federal law, 21 C.F.R. 801.109, is expressly prohibited by Section 468.203(4), F.S., except by an occupational therapist or an occupational therapy assistant who has received training as prescribed in this rule.

Ms. Gantt requested a Declaratory Statement from the Board stating the Hivamat 200 is not an electrical stimulation device and does not require specialty certification in order for an occupational therapist or an occupational therapy assistant to use it for treatment of patients.

MOTION: After discussion, Mr. Spafford made a motion to deny the issuance of the declaratory statement due to the lack of technical information regarding the Hivamat 200 to make an informed decision. The motion was seconded by Ms. McKenzie and carried with a 3/0 vote.
