**DISCIPLINARY PROCEEDINGS**

**VOLUNTARY RELINQUISHMENT**

TAB 1            Victoria Salani, O.T., DOH Case #2016-28809 OT16702, File #15651  
(PCP waived)

Ms. Salani was not present nor represented by Counsel.

Ms. Gilani summarized the case for the Board. Ms. Salani was charged with the following allegations: Section: 456.072(1)(k)(z)(dd)(hh) and 468.217(1)(t)(x), Florida Statutes (No

Administrative Complaint, allegations listed from Investigative Report)

The case was presented as a motion of Board's Final Order by Voluntary Relinquishment.

**MOTION:** Mr. Spafford made a motion to accept Ms. Salani's Voluntary Relinquishment of her occupational therapist license. The motion was seconded by Ms. McKenzie and carried with a 4/0 vote.

## **SETTLEMENT AGREEMENT**

**TAB 2            Marilyn Sheehy, O.T., DOH Case #2015-07347, OT8715, File #7326**  
(PCP Members - Johnson and McKenzie)

Ms. Sheehy was present with legal counsel, Ms. Jodie G. Barrett and proposed supervisor/monitor Ms. Posner. All were sworn in by the court reporter.

Ms. Giliani presented the case to the Board stating as a one-count Administrative Complaint alleging Ms. Sheehy made or filed a report which she knew to be false. Ms. Sheehy completed, signed, and submitted occupational therapy treatment notes for treatment not rendered. Ms. Sheehy indicated she treated Patient M.F. on several dates in December 2014 and January 2015 when the Patient's mother states Ms. Sheehy did not, in fact, treat Patient M.F. on those dates.

Ms. Sheehy disputed some of the material facts contained in the Administrative Complaint, but entered into a Settlement Agreement to resolve the matter to the satisfaction of the Board rather than going before the Division of Administration. Accordingly, the Settlement Agreement was before the Board in lieu of litigation.

Additionally, Ms. Gilani noted in a Memo to the Board the following:

- Ms. Sheehy has been licensed for 18 years with no prior discipline.
- The terms of the Settlement Agreement are above the disciplinary guidelines for such an offense.
- Ms. Sheehy disputed some of the material facts alleged.
- Ms. Sheehy stated she submitted this documentation with the intent to provide the therapy in the future, some of which she claimed to have provided prior to her termination.
- Ms. Sheehy stated she was going through an emotional time during the months in question due to her mother's chronic illness and subsequent death.

Terms of the Settlement Agreement as presented:

- \$500 fine
- Reimbursement of Costs (\$1,594.65)
- 1 year of probation with conditions

**MOTION:** After discussion, Mr. Spafford made a motion to reject the Settlement Agreement as presented. The motion was seconded by Ms. Banta and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a counter offer to the settlement agreement to include chart reviews and allowing supervisor's practice to be within 50 miles of the licensee's practice, along with other terms of the original agreement. The motion was seconded by Ms. Banta and carried with a 3/0 vote.

**MOTION:** Ms. McNulty reiterated the previous motion for clarification and Mr. Spafford moved to again accept the countered motion to include chart reviews and allowing supervisor's practice to be within 50 miles of the licensee's practice, along with other terms of the original agreement as follows below.

- Fine: \$500 within 2 years of the FO filing date;
- Costs: \$1,549.65 within 2 years of the FO filing date;
- Probation: 1 yr. of indirect supervision by a Board-approved monitor/supervisor per original terms + review of 10% of charts representative of workload at each employment setting – any changes in employment/supervisor to be submitted to compliance officer;
- Appearances: First appearance w/supervisor after commencement of probation and at the conclusion of probation; and
- Reports: Quarterly from the supervisor and respondent

Mr. Arthur seconded the motion, which carried with a 3/0 vote.

Ms. Barrett, Ms. Sheehy's Attorney, stated for the record that Ms. Sheehy accepted the revised terms of the Settlement Agreement, and Ms. Oaj Giliani also agreed.

**MOTION:** After discussion, Ms. Banta made a motion to approve Ms. Chaya Posner, OT 9634 as Ms. Sheehy's monitor/supervisor. Mr. Arthur seconded the motion, which carried with a 3/0 vote.

**MOTION:** After discussion, Ms. McKenzie made a motion to approve Ms. Steven's application for licensure. The motion was seconded by Ms. Banta and carried with a 4/0 vote.

#### **TAB 5. Melanie Harley, OT18182, File #17959**

Ms. Harley was present with Ms. Maria Hinds, FAMU Professor/Administrator and both were sworn in by the court reporter.

Ms. Harley's AHCA Exemption application for disqualification from employment was before the Board for review.

**MOTION:** After discussion, Mr. Spafford made a motion to approve Ms. Harley's application for Exemption from Disqualification from Employment. The motion was seconded by Mr. Arthur and carried with a 4/0 vote.

The motion was seconded by Mr. Arthur and carried with a 4/0 vote.

**MOTION:** Mr. Spafford moved to approve the Examination with Waiver ratification list of 9 applicants for licensure (APPENDIX 5), and the Addendum list of 3 names (APPENDIX 6) totaling 12 names. The motion was seconded by Ms. McKenzie and carried with a 4/0 vote.

**MOTION:** Ms. McKenzie moved to approve 10 continuing education providers. The motion was seconded by Ms. Banta and carried with a 4/0 vote.

Ms. McKenzie moved to approve 7 Prevention of Medical Errors course providers. The motion was seconded by Ms. Banta and carried with a 4/0 vote.

Ms. McKenzie moved to approve 2 Florida Laws and Rules course providers. (APPENDIX 7) The motion was seconded by Mr. Spafford and carried with a 4/0 vote.

**NEW BUSINESS**

**TAB 10 Voting Conflict Form**

Mr. Hall addressed this item to the Board.

Form 8A, Memorandum of Voting Conflict for State Officers, is to be completed by any person serving at the State level of government on an appointed or elected board, council, commission, authority, committee, or as a member of the Legislature. It applies to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

This form is required in instances where a board member is recused due to a financial conflict.

The form was provided for the members review and is available from staff, in the event a member should recuse themselves under such circumstances.

The Assistant Attorney General can address any questions regarding the form or any inquiry related to the need for recusal.

**TAB 11 Minor Violations and Notice of Noncompliance**

In the 2016 Legislative Session, HB 183 was passed. One of the provisions of this legislation was an amendment to section 120.695, F.S., related to the designation of minor violations.

The legislation provided in part:

(b) Each agency shall review all its rules and designate those for which a violation would be a minor violation and for which a notice of noncompliance must be the first enforcement action taken against a person or business subject to regulation. A violation of a rule is a minor violation

if it does not result in economic or physical harm to a person or adversely affect the public health, safety, or welfare or create a significant threat of such harm.

(c) 1. No later than June 30, 2017, and after such date within 3 months after any request of the rules ombudsman in the Executive Office of the Governor, each agency shall review its rules and certify to the President of the Senate, the Speaker of the House of Representatives, the committee, and the rules ombudsman those rules that have been designated as rules the violation of which would be a minor violation.

Each Board has a Notice of Noncompliance rule that specifies which violations are considered a minor violation. In order to comply with the June 30, 2017, deadline each profession was asked to review their rules and determine if any additional violations should be noted as a minor violation.

In the 2016 Legislative Session, HB 183 was passed. One of the provisions of this legislation was an amendment to section 120.695, F.S., related to the designation of minor violations.

The legislation provided in part:

(d) Each agency shall review all its rules and designate those for which a violation would be a minor violation and for which a notice of noncompliance must be the first enforcement action taken against a person or business subject to regulation. **MOTION:** After discussion, Ms. McKenzie made a motion the Board agrees Rule 64B11-4.004, F.A.C., meets the legislative requirements and that Board Counsel may work with the Board Chair on any additional actions that may be needed towards meeting the June 30<sup>th</sup> deadline. The motion was seconded by Ms. Banta and carried with a 4/0 vote.
