Mr. Ordonez-Rocha's OTA by Endorsement application was presented to the Board as an Individual Consideration due to an affirmative response to previous criminal history question on the application.

MOTION: After discussion, Mr. Spafford made a motion to table/continue Mr. Ordonez-Rocha's application for licensure requiring a Personal Appearance after the resolution of his current open April 2018 Criminal cases. The motion includes the option to Mr. Ordonez-Rocha to seek a PRN evaluation, and come before the Board with PRN's resolution (evaluation or a monitoring contract) prior to the resolution of the closed cases
