DISCIPLINARY PROCEEDINGS

INFORMAL HEARING

TAB 1 Michael Juzwa, DOH Case Number 2016-07756
OT9265, File #8671 (PCP Members – Johnson & McKenzie)

Mr. Juzwa was not present for the meeting and not represented by legal counsel.

Ms. Giliani presented the case to the Board as an Informal Hearing. The Administrative Complaint in this case charges Respondent with violating Section: 468.217(1)(v), Florida Statutes (2015), providing that a lawful order of the board or department previously entered in a disciplinary hearing constituting grounds for disciplinary action by the Board. The terms of the previous Final Order, required Respondent to make 5 (five) annual payments of \$2,250 and \$600 towards the fine and costs, to be paid by October 1st of each year. Respondent failed to pay his 2015 annual payments in full.

Respondent does not dispute the allegations and elected an informal hearing before the Board. Additionally,

Ms. Gilani noted in Memos to the Board the following:

- 2015 Annual Payment: Respondent made a partial payment of \$1,425 on September 28, 2015 and paid the remainder on April 5, 2017.
- 2016 Annual Payment: Respondent made partial payment of \$1,425 on May 26, 2017, but still owes \$1,425.

Additionally, Tawanda Burnett, Compliance Officer, noted in an updated Board Case Summary received on July 18, 2017, stating Mr. Juzwa is currently now in compliance with terms of his final order and his balance is \$2,850.00 due on or before October 1, 2017.

MOTION: Mr. Spafford moved to find the Respondent was properly served and elected an informal hearing. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to adopt the materials under Tab 1 and any addendum items into evidence in this proceeding. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to find that the material facts as alleged in the Administrative Complaint are not in dispute and adopt these findings of fact as set forth in the Administrative Complaint as their own. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to adopt the allegations of laws as set forth in the Administrative Complaint as the conclusions of law. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to the Respondent is in violation of the practice act as charged in the Administrative Complaint. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: After discussion, Mr. Arthur made a motion to approve the Department's recommended penalty and imposed a \$1500.00 Fine to be paid within one(1) year of the Final Order filing date. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to access \$282.21 in costs, also to be paid within 1 year of the filing of the final order. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

INFORMAL HEARING

TAB 2 Claudia Milena Ganem, DOH Case Number 2017-00880 OT14896, File #14498 (PCP Members – Johnson & McKenzie)

Ms. Ganem was present, sworn in by the court reporter and represented by legal counsel, Ms. Barbara L. Kornblau, Esq.

Ms. Giliani presented this case to the Board as an Informal Hearing stating the Respondent is guilty of violating: Section: 456.072(1)(c), Florida Statutes (2014). The Administrative Complaint charges Respondent with being convicted of a crime related to the practice of occupational therapy for being adjudicated guilty of Conspiracy to Commit Racketeering Influence and Corrupt Organization on August 29, 2014.

Respondent does not dispute the allegations and requested an informal hearing before the Board to provide oral and/or written statements for the purpose of mitigation.

MOTION: Mr. Spafford moved to find the Respondent was properly served and elected an informal hearing. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to adopt the materials in Tab 2 and any addendum items into evidence in this proceeding. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion that the Board find that the material facts as alleged in the administrative complaint are not in dispute and to adopt the findings of fact as set forth in the Administrative Complaint as the Board's own in this proceeding. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion that the Board adopt the allegations of law in the Administrative Complaint as the Board's conclusions of law in this proceeding. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: After discussion, Mr. Spafford made a motion that Respondent violated the Florida Statutes as charged in the Administrative Complaint and imposed the following penalties:

- Fine: \$1,000.00 to be paid within six (6) months of the Final Order filing date;
- Six (6) months Probation
 - Indirect, if in non-clinical setting;
 - Direct, if in clinical setting must notify Compliance and submit Curriculum Vitae of supervisor for approval by Chair prior to practicing in a clinical setting;
 - May not direct bill. Billing must be done as a "rendering provider" under another authorized provider/facility.

- Reports: Every 90 days during the probationary period.
- Tolling provision to be included in order.
- No Board appearance required for Supervisor approval or at end of probation

The motion was seconded by Ms. Banta and carried with a 5/0 vote.

MOTION: Mr. Spafford made a motion to access \$22.56 costs to be paid within 6 months of the filing date of the Final Order. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

VOLUNTARY RELINQUISHMENT

TAB 3 Cassandra Anne Falter-Hajec, DOH Case Number 2017-02670 OT16526, File #16125 (PCP waived)

Ms. Falter-Hajec was not present and not represented by legal counsel.

Ms. Giliani presented this case to the Board stating the Respondent was charged with the following allegations: Section: 456.072(1)(k)(z0(dd)(hh) and 468.217(1)(h)(t)(x), Florida Statutes as reported in the Investigative Report. The case was presented as a motion of Board's Final Order by Voluntary Relinquishment. Respondent executed a Voluntary Relinquishment of Licensure prior to an Administrative Complaint being presented to a probable cause panel. The relinquishment was filed with the Agency Clerk Respondent's occupational therapist license, license number OT 16526.

MOTION: After discussion, Mr. Spafford made a motion to accept Voluntary Relinquishment of Ms. Falter-Hajec's occupational therapist license. The motion was seconded by Ms. Banta and carried with a 5/0 vote.
