**GENERAL BUSINESS**

**POST-DISCIPLINARY PROCEEDING**

**TAB 1            Michael Juzwa, OT9265, File #8671**

Mr. Juzwa was present on the conference call and not represented by legal counsel.

Mr. Juzwa petitioned to appear before the Board submitting a Termination of Probation Request, in regards to DOH Case Number: 2010-03103. Mr. Juzwa was placed on probation by the Board equaling 5 years, to include: direct supervision under a Board approved monitor/supervisor, quarterly reports, continuity of practice with tolling provisions when in active practice, Board appearances, notification of permanent employment and setting restrictions. Mr. Juzwa is prohibited from being employed in a home-health setting, is only allowed to practice in an office setting, clinic, hospital, or nursing home. Additionally, Mr. Juzwa was fined by the Board \$11,250.00 including costs equaling \$3,000.00, and an \$850.00 balance was due on 10/01/2017

at the time the Board agenda was prepared, having previously submitted payment total of \$10,400.00.

Mr. Juzwa's license has been on probation since October 1, 2012. Probation was tolled as of January 11, 2013. Mr. Juzwa lapsed in his payments, however, has since remitted all fines and costs.

At the time of the meeting, Mr. Juzwa's outstanding requirements remained, to include 5 years' probation, which has been tolled, as he has not worked in the profession, (to include direct supervision under a Board approved monitor/supervisor), quarterly reports and the permanent employment-setting restrictions of no home-health employment-setting.

Mr. Juzwa submitted a request for the Board to terminate his probation stating that he has not been able to find work in his field because of his probation restrictions.

**MOTION:** After discussion, Mr. Spafford made a motion to **deny** Mr. Juzwa's Termination of Probation request. The motion was seconded by Ms. Banta and carried with a 5/0 vote.

## ADMINISTRATIVE PROCEEDINGS

### PERSONAL APPEARANCE

#### TAB 3 Mario Anzalone, OT by Endorsement, File #18085

Mr. Anzalone was present on the conference call and represented by legal counsel Erica Denise Moore, Esquire.

During the July 31, 2017 OT Board Meeting, Mr. Anzalone's application for OT licensure was before the Board for review of pending discipline related to the filing of a public Administrative Complaint against his Florida PT License No. 26322 on December 16, 2016. The complaint alleged violations of Section 456.072(1)(n), F.S. (2014) and Rule 64B17-6.001(2)(f), F.A.C. (2014), regarding exercising influence on a patient or client for the financial gain of the licensee or a third party.

After review of Mr. Anzalone's OT licensure application, as well as the complaint pending against his PT license, the OT Board required Mr. Anzalone make another personal appearance once the PT Board had the opportunity to consider disciplinary action at its August 4, 2017 meeting.

The PT Board entered into a Settlement Agreement with Mr. Anzalone imposing the following discipline on his PT license:

- Restriction against practicing in *any* in-home treatment setting for 3 years;
- Restitution to the Patient in the amount of \$32,181.56 within 5 years;
- Agreement with the statement that he would never allow a current or former patient to reside in his personal home, as well as acknowledgement of the importance of maintaining professional boundaries;
- 1 year of indirect supervision by a Florida-Licensed PT;
- Costs in the amount of \$2,000 within 5 years;
- Completion of live continuing education credits approved by the PT Board's Education Liaison; and
- Passage of the Florida Physical Therapy Laws & Rules Exam within 1 Year.

**MOTION:** After discussion, Mr. Calvo made a motion to **deny** Mr. Anzalone's application for licensure pursuant to Sections 468.217(2), and 456.072(2), Florida Statutes, stating the Board may refuse to certify an applicant for licensure, restrict the practice of the licensee, or impose a penalty, based on fact that Mr. Anzalone's application reveals that his license to practice has been acted against by the Florida Board of Physical Therapy, in violation of Section 456.072(1)(f), F. S., (Final Order No. DOH-17-1518-S-MQA, filed August 21, 2017, in Case No. 2015-11985).

The motion was seconded by Ms. Banta and carried with a 4/1 vote, with one opposing vote registered by Mr. Arthur.

#### TAB 15 Jessica Lynn Smith, OT by Endorsement, File #18720

Ms. Smith was present on the conference call and not represented by legal counsel.

Ms. Smith's OT by Endorsement application was presented to the Board as an Individual Consideration due to her affirmative response to previous disciplinary history questions on the application.

Mr. Carrone's AHCA Exemption from disqualification from employment application was before the Board due to a previous background level II screening reflecting previous criminal history.

**MOTION:** After discussion, Mr. Spafford made a motion to **grant** Mr. Carrone's exemption for disqualification from employment. The motion was seconded by Mr. Arthur and carried with a 5/0 vote.

- **Rule 64B11-2.003, F.A.C., Fees; Application**

Ms. McNulty requested a modification on the application, in the New Graduate Instructions page #2 , #3 requesting the same language as added on page 3, #3 to include at the end of the sentence, *“and all other relevant items are acceptable”*.

**MOTION:** After discussion, Mr. Spafford made a motion that the Rule amendments will not have an adverse impact on small business, and is not likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida, within 1 year after the implementation of the rule. The motion was seconded by Mr. Arthur and carried with a 5/0 vote.

**MOTION:** Mr. Spafford made a motion that this Rule does not present a first-time violation of the amendments and should not be added to the non-compliance rule. The motion was seconded by Mr. Arthur and carried with a 5/0 vote.
