DETERMINATION OF WAIVER

TAB 1 Michelle Burkhard, DOH Case #2016-15706

OTA 9958, File #2824 (PCP: Johnson & McKenzie)

Ms. Burkhard was not present for the meeting and not represented by legal counsel.

Mr. Fryson presented this case to the Board as a Determination of Waiver stating the

Administrative Complaint alleges Respondent is guilty of violating: Section 468.217(1)(v), Florida statutes (2015).

MOTION: Mr. Spafford made a motion to accept the Investigative Report into evidence for purposes of imposing a penalty. The motion was seconded by Dr. Banta and carried with a 3/0 vote.

MOTION: Mr. Spafford moved to find the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Ms. German and carried with a 3/0 vote.

MOTION: Mr. Spafford made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Ms. German and carried with a 3/0 vote.

MOTION: Mr. Spafford made a motion to adopt the conclusions of laws as set forth in the Administrative Complaint finding it constitutes a violation of the Practice Act. The motion was seconded by Ms. German and carried with a 3/0 vote.

MOTION: After discussion, Dr. Banta made a motion to impose the penalties as listed. The motion was seconded by Ms. German and carried with a 3/0 vote.

TAB 11 Liana Valla, OT 8444, F#7119, re: Chapter 468.203(3) & (4), F.S., Definitions

Ms. Valla was not present for the meeting. The Board discussed the petition submitted by Ms. Valla, regarding the practice of neurofeedback and stated the following issues and questions:

- More information is needed regarding the device: How is this device regulated? Is it regulated? By whom, if yes. Why is this device not required to be "prescriptive", or considered "non-invasive" when petition states it leads to neuroplasticity changes, as it stimulates the brain, and its outcome effects the brain's condition?
- Who, and what are the credentials of the supervising "practicing clinician"?
- Training concerns/questions, regarding the kind of training, and how to determine how much training is required for one to get "satisfactory confident?"

MOTION: After discussion, Dr. Banta made a motion to table/continue Ms. Valla's petition until the next meeting of the Board, and asked staff to send a letter requesting additional information/answers to questions as discussed to better understand Neurofeedback. The motion was seconded by Ms. German and carried with a 3/0 vote.

Mr. Hall thanked Board members, Mr. Spafford and Ms. German, for attending the Board's Chair meeting.

TAB 19 Staff Recognition

Presented as informational items.

Mr. Spafford commended Board staff for the continual flow of positive affirmations received in the Board office. Mr. Hall stated he publicly wanted to thank Ms. King and staff, Ms. Horton and Ms. Boutwell, for the wonderful job they do and spoke to the Board regarding how efficient staff has worked to stream line the licensing process. He explained to the Board regarding the Department's measures and expectations for the review of applications and licensure. Mr Hall provided the following statistics from the past fiscal year: Regarding the 30-day measures: a total of 1389 OT and OTA applications were processed, and applicants were notified or licensed within 3.1 days average. Regarding the 90-day measures: within 1.42 days (a 54% reduction from last year) reviews were completed. Of those applications, for everything to be complete, including the delays on applications staff has no control of, such as applications submitted waiting for exam scores, deficiencies to be met, for Board reviews, etc., within 4.7 days (a 27% reduction from last year) were completed. Of the total 1389 applicants, those eligible for licensure, were licensed within 9.64 days (a 60% reduction from last year which was at 24 days in the last fiscal year).

Ms. King added these numbers were reached even with one of two staff members, Ms. Horton was absent for 3.5 months maternity leave, and commended Ms. Boutwell.

Ms. Judie Johnson also commended the Board staff, remembering in previous years licensing was taking 6 weeks.
