**GENERAL BUSINESS**

**DISCIPLINARY PROCEEDING**

**DETERMINATION OF WAIVER**

**TAB 1** Kristabelle Gruchow, DOH Case #2016-00295  
OT17230, File #16895 (PCP, Johnson & Banta)

Ms. Gruchow was not present for the meeting and was not represented by legal counsel.

Mr. Fryson presented this case as a Determination of Waiver and summarized the case for the Board. Respondent was charged with the following violations: Section 456.072(1)(aa), Florida Statutes (2015) and Section 468.217(1)(x), Florida Statutes (2015), having tested positive for a drug as defined in Section 112.0455, F.S., on a confirmed pre-employment drug screening. Respondent did not provide a lawful prescription and legitimate medical reason for the drug use.

**MOTION:** Mr. Spafford made a motion to accept the Investigative Report into evidence for purposes of imposing a penalty. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford moved to find the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion to adopt the conclusions of laws as set forth in the Administrative Complaint finding this constitutes a violation of the Practice Act. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** After discussion, Mr. Spafford made a motion to impose the following penalties:

- Licensure Suspension until Respondent demonstrates the ability to practice with reasonable skill and safety.
- A Professionals Resource Network (PRN) evaluation submitted to the Board as part of determination for reinstatement.
- \$500 Fine to be paid within one (1) year of the filing date of the Final Order.
- Board reserves jurisdiction to impose additional terms and conditions based on the PRN evaluation, including probation, if any.

The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion to impose the costs of \$1875.75 to be paid within one year of the filing date of the Final Order. The motion was seconded by Ms. German and carried with a 3/0 vote.

## **INFORMAL HEARING**

**TAB 2**            **Heidi Lynn Donley, DOH Case #2017-23947**  
OTA 14512, File #7719 (PCP: Johnson & Banta)

Ms. Donley was present, sworn in by the court reporter and represented by legal counsel, Paul Kwilecki, Esquire.

Mr. Fryson presented this case as an Informal Hearing and summarized the case for the Board. Respondent was charged with the following violation: Section 468.217(1)(x), Florida Statutes (2016), and Section 456.072(1)(m), Florida Statutes (2016) having made deceptive, untrue, or fraudulent representation by signing her OT supervisor's name, Elizabeth K. Palma, O.T., on a Fieldwork Performance Evaluation form as the evaluator and/or supervisor of an Occupational Therapy Assistant student.

**MOTION:** Mr. Spafford made a motion to accept the Investigative Report into evidence for purposes of imposing a penalty. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford moved to find the Respondent was properly served Respondent was properly served, does not dispute the issues of material fact alleged in the

Administrative Complaint and requested an informal hearing. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion to adopt the conclusions of laws as set forth in the Administrative Complaint. The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion that these finding constitutes a violation of the Practice Act. The motion was seconded by Ms. German and carried with a 3/0 vote.

Mr. Kwilecki, stated for clarification, there are no disputed facts in this case.

**MOTION:** After discussion, Mr. Spafford made a motion to impose the following penalties:

- One (1) year of Probation from the filing date of the Final Order. Probation includes:
  - Submission of Quarterly reports from the Respondent and the OT Supervisor;
    - Reports are to include review of charts for 10% of clients served, and the Supervising OT's documentation of their reviews, regarding the Respondent's supervision of students;
  - Respondent is to appear before the Board prior to termination of probation, however, the Supervisor is not required to appear.
- Sixteen (16) hours of continuing education in the subject of ethics to be completed within 1 year of the filing date of the Final Order.
- \$1500 Fine to be paid within two (2) years of the Final Order's filing date. This includes a \$500 fine for violation of Section 468.217(1)(x), Florida Statutes (2016), and \$1000 fine for violation of Section 456.072(1)(m), Florida Statutes (2016). The board reduced this fine below the disciplinary guidelines, due to mitigating factors, including:
  - Respondent has no previous discipline.
  - Respondent's efforts to correct the error/issue.
  - Respondent has been retained for employment by current employer.

The motion was seconded by Ms. German and carried with a 3/0 vote.

**MOTION:** Mr. Spafford made a motion to impose costs of \$762 to be paid within two (2) years of the filing date of the Final Order. The motion was seconded by Ms. German and carried with a 3/0 vote.

#### **Tab 4 Nicolas Ordonez-Rocha, OTA by Endorsement, File #9676**

Mr. Ordonez-Rocha was present, sworn in by the court reporter and not represented by legal counsel.

He was requested to appear before the board due to an affirmative response to the criminal history section on the application.

Dr. Martha Brown, Associate Medical Director for the Professionals Resource Network (PRN) was present with applicant and addressed the Board. Dr. Brown stated Mr. Ordonez-Rocha has completed his evaluation, and PRN administration has not had time to complete the evaluation letter to the Board. However, PRN will be offering Mr. Ordonez-Rocha a monitoring contract as suggested by the evaluator.

Mr. Ordonez-Rocha waived the 90-days requirement for the Board's action on his application.

**ADDENDUM: INDIVIDUAL CONSIDERATIONS**

**TAB 22. Merry Gasorek, OTA by Exam with Waiver, File #10035**

Ms. Gasorek was not present for the meeting and not represented by legal counsel.

Ms. Gasorek's application was presented to the Board due to she applied under the Examination with Waiver method, which requires the applicant hold an active license and provide proof of having been previously certified with the National Board of Certification for Occupational Therapy (NBCOT). NBCOT does not have record Ms. Gasorek was ever officially certified with the organization. However, Ms. Gasorek has provided documentation from the NBCOT's predecessor, the American Occupational Therapy Association (AOTA), that she successfully passed the AOTA Certification Exam for Certified Occupational Therapy Assistant in July 1978. Ms. Gasorek's statement regarding these matters and her communication efforts with the NBCOT to resolve the certification issue were presented to the Board. Although her application is technically incomplete, Ms. Gasorek requested October 10, 2018 that her application be considered by the Board as-is for licensure.

**MOTION:** After discussion, Ms. Vizvary made a motion to approve Ms. Gasorek's application for licensure. The motion was seconded by Ms. German and carried with a 3/0 vote.

**TAB 23. Staci Starcher, OTA by Endorsement, File # 9928**

Ms. Starcher was present, sworn in by the court reporter and not represented by legal counsel.

Her application was presented to the Board due to an affirmative response to the criminal history section on the application.

**MOTION:** After discussion, Ms. German made a motion to approve Ms. Starcher's application for licensure. The motion was seconded by Ms. Vizvary and carried with a 3/0 vote.

**PETITION FOR DECLARATORY STATEMENT**

**TAB 11 Liana Valla, OT 8444, F#7119, re: Chapter 468.203(3) & (4), F.S., Definitions**

Ms. Valla was present for the meeting, sworn in by the court reporter and not represented by legal counsel.

At the July 30, 2018 meeting, the Board discussed the petition submitted by Ms. Valla, and moved to table/continue Ms. Valla's petition regarding the practice of neurofeedback and requested additional information/answers from Ms. Valla to the following questions as discussed:

- More information is needed regarding the device: How is this device regulated? Is it regulated? By whom, if yes. Why is this device not required to be "prescriptive", or considered "non-invasive" when petition states it leads to neuroplasticity changes, as it stimulates the brain, and its outcome effects the brain's condition?
- Who, and what are the credentials of the supervising "practicing clinician"?
- Training concerns/questions, regarding the kind of training, and how to determine how much training is required for one to get "satisfactory confident"?

After discussion, it was noted additional clarification is still needed regarding whether neurofeedback devices require a prescription, regardless of reimbursement method.

**MOTION:** After discussion, Ms. German made a motion to allow the withdrawal of Ms. Valla's petition and to initiate Rule Development for Rule 64B11-4.001, F.A.C., Use of Prescription Devices for the February 25, 2019 meeting of the Board. The motion was seconded by Ms. Vizvary and carried with a 3/0 vote.

The Department is proposing revised health history questions that are intended to be less intrusive, and ensure people are not dissuaded from seeking the treatment they need, while still remembering the purpose of licensure is to ensure the health, safety and welfare of the public. The revised proposed language/questions were added to the application for the Board's review and/or approval.

The Board discussed and were remiss in removing the language *"In the last 5 years"* from the application questions.

Dr. Brown, PRN, addressed the Board and commented in agreement, that PRN was concerned about the Department's Boards removing the time segments from the application questions.

**MOTION:** After discussion, Mr. Spafford made a motion to open Rule 64B11-2.003, F.A.C., Fees; Application for Rule Development at the February 25, 2019 meeting of the Board. The motion was seconded by Ms. German and carried with a 3/0 vote.
